Heard Ms. P Barua, learned counsel for the petitioner, who submits that the petitioner retired as Principal from Murkong Selek College, Jonai as Lecturer on 31.12.2018 and that on account of overstay in service from 01.01.2018 to 31.12.2018 and for wrong fixation of pay scale on 01.10.2006 and 01.10.2011, the respondent authorities concerned have recovered/deducted an amount of Rs. 21,27,846/- from her pension and other benefits. The learned counsel submits that the wrong fixation of pay and the overstay in service is not the fault of the petitioner and the petitioner was never informed at any point of time that her date of birth was wrongly recorded in her Service Book and therefore, such being the position, the recovery from her pension and other benefits cannot be done and the same should be refunded back to her. In support of her submission, the learned counsel has relied upon the judgment of the Apex Court in the case of ***State of Bihar & Ors. vs. Pandey Jagdishwar Prasad***, reported in ***(2009) 3 SCC 117***.

In view of above, issue notice of motion, returnable by 20.10.2022.

Mr. K Gogoi, learned counsel appears and accepts notice on behalf of respondent Nos. 1 and 4, Ms. R Nath, learned counsel appears and accepts notice on behalf of respondent

No. 3, Mr. A Chaliha, learned counsel appears and accepts notice on behalf of respondent Nos. 2 and 8 while Mr. P Saikia, learned counsel appears and accepts notice on behalf of respondent No. 5.

to 31.12.2018 as well as alleged wrong fixation of pay scale despite the Service Book being checked and verified at regular intervals during the service period and without any proceeding being drawn against the petitioner during service tenure and the recovery being made after the retirement of the petitioner from the pension and other benefits.

Dolung), P.O. Jonai in the district of Dhemaji, Assam and such she is entitled to all the rights and privileges guaranteed under the Constitution of India and other laws made thereunder.

2. That the petitioner joined Murkong Selek College, Jonai in the capacity of a Lecturer on 01.10.1993 with an initial pay fixed at Rs.2200/- as basic pay per month with due increments from time to time. The petitioner had been discharging her duties with sincerity and without any break till the date of her retirement as a Principal of Murkong Selek College, Jonai on 31.12.2018. During her service tenure, neither any notice nor any departmental proceeding was initiated against the petitioner.
3. That the petitioner's date of birth was originally recorded in the Service Book as 01.12.1958 instead of 01.12.1957. Accordingly, the petitioner attained the age of superannuation on 31.12.2017. However, perhaps due to wrong recording of the date of birth of the petitioner in the Service Book, the petitioner was not issued any notice informing her about her retirement date and the petitioner continued to work till 31.12.2018, on which date the petitioner was

released from the post of Principal. It is seen that the Service Book of the petitioner was verified from time to time by the concerned authority.

Copies of the Service Book along with typed copy of the relevant portion and the Retirement Certificate issued by the Principal (i/c), Murkong Selek College, Jonai are annexed herewith and marked as **Annexures-I and II** respectively.

4. That thereafter, the particulars/documents for pension and the pension proposal with regard to the petitioner were forwarded to the Director of Higher Education Assam. It also came to the knowledge of the petitioner that a meeting of the Governing Body of Murkong Selek College, Jonai took place on 19.03.2019 and in that meeting, it was resolved that the overstay for a period of 12 months w.e.f. 01.01.2018 to 31.12.2018 will be intimated to the Directorate of Higher Education.

Copies of the letter dated 05.02.2019 and the Abstract of the Governing Body resolution dated 18.11.2019 are annexed herewith and marked as **Annexures- III and IV** respectively.

5. That after the process of verification of pension papers, the pension proposal of the petitioner along with the documents were returned to the Principal, Murkong Selek College, Jonai vide a letter No. DHE/PEN/411/2019/, dated 25.11.2019 stating anomalies in the nature of overstay in service from January 2018 to December 2018 and wrong fixation of pay scale on 01.10.2006 and 01.10.2011 amongst others. It was further requested to resubmit the pension proposal after making necessary rectifications and revising the entries in the Service Book along with a due and drawn statement for the overstayed period in service and the 7th UGC pay scale.

Copy of the letter dated 25.11.2019 is annexed herewith and marked as **Annexure-V**.

6. That accordingly, a salary statement along with the overdrawal UGC arrear statement with regard to the alleged overstay period from 01.01.2018 to 31.12.2018 was prepared by the Principal, Murkong Selek College, Jonai showing net refundable amount of Rs. 14,63,984.00 (Rupees Fourteen Lakh Sixty Three Thousand Nine Hundred Eighty Four) and Rs. 2,63,841.00 (Rupees Two Lakh Sixty Three Thousand Eight Hundred Forty One) respectively. Along with the aforementioned salary statement, a 10 month salary statement from the period 01.03.2018 to 31.12.2018 was prepared by the President, Governing Body, Murkong Selek College, Jonai.

Copies of the salary statement, UGC arrear statement and 10 month salary statement are annexed herewith and marked as **Annexures- VI, VII and VIII** respectively.

7. That pursuant to submission of the aforesaid documents as was required by the Directorate of Higher Education, Assam, the pension proposal with

regard to the petitioner was forwarded to the Accountant General, Assam vide letter No. DHE/PEN/411/2019/92, dated 03.03.2020. and thereafter, the pension of the petitioner was finalized on the basis of the Last Pay Drawn at Rs. 65000.00 (Rupees Sixty Five Thousand) which the petitioner is receiving till date. However, despite having served as the Principal till 31.12.2018, very arbitrarily the date of retirement was taken as 31.12.2017.

Also, it came to the knowledge of the petitioner that vide an Order dated 18.11.2020, an amount of Rs. 15,00,000.00 (Rupees Fifteen Lakh) was sanctioned as a payment against Death cum Retirement Gratuity (DCRG) after making deduction of an amount of Rs. 21,27,846.00 (Rupees Twenty One Lakh Twenty Seven Thousand Eight Hundred Forty Six) as deduction against overpayment of pay and allowances of which an amount of Rs. 6,27,846.00 was proposed to be recovered from the arrear and future reliefs. Being aggrieved by the arbitrary and illegal action on the part of the respondent authorities in deducting the amount of Rs. 21,27,846/-, the petitioner has approached this Hon'ble Court.

Copies of the letter dated 03.03.2020, Pension Payment Order and Order dated 18.11.2020 are annexed herewith and marked as **Annexures-IX, X and XI** respectively.

8. That it is the submission of the petitioner that the petitioner retired as the Principal of Murkong Selek College, Jonai and the petitioner is no way involved in maintenance of the Service Book and as such, has no hand in the alleged overstay in service. In fact, the petitioner was not issued any notice till the date of retirement on 31.12.2018 or prior to the intimation dated 02.03.2019. Under these circumstances, as per the settled law when the petitioner is not at fault or for that matter has no role in manipulation of records for overstay in service, the petitioner cannot be penalized for overstay.
9. That in the Service Book of the petitioner, it has been stated that the petitioner rendered her service till 31.12.2018 i.e. the date of retirement of the petitioner and the petitioner also states that the petitioner has been paid salary till 31.12.2018. As such, considering

the date of retirement as 31.12.2017 for the purpose of pension is totally incorrect and unjust and thereafter deducting the salary that was paid to the petitioner from 01.01.2018 to 31.12.2018 is arbitrary and against the settled principles of law.

10. That the petitioner was in no way responsible for over stay in service as alleged and in fact, the respondent authorities are the custodian of the records including the Service Book of the petitioner. In such circumstances, the petitioner cannot be made liable for such recovery and as such, the petitioner is not liable to refund the alleged overdrawal of monthly salary due to over stay in service. Moreover, on no occasion during the service tenure, the petitioner was informed by any notice regarding the date of retirement or that there was any mistake in recording the date of birth in the Service Book. The petitioner had served and performed her duties till 31.12.2018 and as such though the petitioner has overstayed in service that too because of the fault of the respondent authorities, the petitioner cannot be penalised and made to refund such a huge amount. The petitioner is thus entitled to the salary from 01.01.2018 to 31.12.2018 i.e. the

period of alleged overstay as the petitioner had served till then.

11. That the petitioner worked regularly till 31.12.2018 and her service was accepted by the respondents without any objection/dispute about her age and as such, the petitioner is entitled to her salary.

12. That as stated in the letter dated 25.11.2019 (Annexure-V), the other anomaly of wrong fixation of pay scale on 01.10.2006 and 01.10.2011 is due to no fault of the petitioner as the petitioner is not responsible for the said over payment or excess drawal due to alleged wrong fixation of pay and as such, the allegation labeled against her is illegal, arbitrary and baseless. Even if there has been any over payment or excess drawal of salary without the knowledge and understanding of the petitioner and the same being due to no fault of the petitioner, the impugned action of the respondent authorities to deduct and refund the alleged amount or to waive the said amount from the pension on the ground of excess drawal and wrong fixation of pay scale is illegal, unreasonable and arbitrary and liable to be interfered with. Consequent thereof, it is submitted that the respondent authorities may be directed to refund the amount of Rs.

21,27,846.00 (Rupees Twenty One Lakh Twenty Seven Thousand Eight Hundred Forty Six) which has already been deducted back to the petitioner.

13. That the Hon'ble Apex Court in *State of Bihar and Ors vs. Pandey Jagdishwar Prasad*, observed that *since the employee had worked during that period without any objection being raised from the side of the employer State and the employer State had got works done by the employee, it was improper to allow deduction from the retiral benefits, the amount received by him as salary after his actual date of retirement.*
14. That in the decision of the Apex Court in the case of *Shyam Babu Verma and Ors. vs. Union of India and Ors.* reported in (1994) 2 SCC 521, the law in respect of recovery of any excess drawal of salary has been settled. In this case, it was held that *if a higher pay has been received by the employee due to no fault of theirs, it shall only be just and proper not to recover any excess amount which has already been paid to them.* The Apex Court further directed that *'no steps should be taken to recover or adjust any excess amount paid to the petitioner therein due to the fault of the respondents where the petitioners are in no way responsible for the same.*

15. That the said recovery from the retirement dues of the petitioner is harsh, arbitrary and contrary to the mandates laid down by the Hon'ble Apex Court. Since the petitioner is legally entitled to get salaries till her date of retirement i.e. 31.12.2018, as such, any deduction from the pension dues on the ground of over stay in service and over payment of salary and allowance is illegal.

16. That it is also submitted that this is a fit case for the Hon'ble Court to interfere in exercise of its extraordinary jurisdiction under Article 226 of the Constitution of India by issuing a writ in the nature of Certiorari setting aside the Order dated 18.11.2020 (Annexure-XI) whereby a deduction amounting to Rs. 21,27,846.00 (Rupees Twenty One Lakh Twenty Seven Thousand Eight Hundred Forty Six) as recovery against overdrawal during the alleged overstay from 01.01.2018 to 31.12.2018 and re-fixation of pay scale of the petitioner was proposed and/or issue a writ in the nature of Mandamus directing the respondent authorities to refund/release the amount of Rs. 21,27,846.00 (Rupees Twenty One Lakh Twenty Seven Thousand Eight Hundred Forty Six) which has been

recovered all alleged overdrawn monthly salary due to overstay in service and also due to alleged wrong fixation of pay scale on 01.10.2006 and 01.10.2011 from the retiral benefits of the petitioner.

17. That the petitioner has a strong prima-facie case and the balance of convenience is in favour of the petitioner.
18. That the petitioner submits that she has no other alternative, efficacious and speedy remedy except filing this writ petition under Article 226 of the Constitution of India and the remedy sought for, if granted, shall be just and adequate.
19. That the petitioner has a legal right and the legal right has been infringed upon.
20. That the petitioner states that the petitioner has not filed any writ petition earlier regarding the aforesaid facts before the Hon'ble Court as well as its subordinate courts and as such the pendency of any case in connection with the aforesaid facts and circumstance does not arise.

21. That this petition is made bonafide and for the ends of justice.

In the premises aforesaid, Your Lordships may be pleased to admit this petition, call for records, issue a notice/rule directing the respondents to show cause as to why the relieve as prayed for shall not be granted and on such cause or causes being shown, upon hearing the parties and on perusal of records may be pleased to grant the following relief:

- (I) issue a writ in the nature of Certiorari setting aside the impugned order dated 18.11.2020 (Annexure-XI) by which recovery of Rs. 21,27,846/- has been made from the petitioner's retiral benefits on the ground of alleged excess drawal of pay and allowances due to over stay in service from 01.01.2018 to

31.12.2018 and wrong fixation of pay scale on 01.10.2006 and 01.10.2011 and/ or

(II) issue a writ in the nature of Mandamus directing the respondent authorities to refund/release the amount of Rs. 21,27,846/- which has been recovered as alleged over drawal of monthly salary due to over stay and wrong fixation of pay scale from the retiral benefits of the petitioner, and/ or

And upon perusal of the records and considering the show cause, if any, and upon hearing the parties, be pleased to make the Rule absolute, and/or pass such order/orders as the Hon'ble Court deem fit and proper in the facts and circumstances of the case.

And for this act of kindness the petitioner as in duty bound shall ever pray.






